NMT must have this documented in every federal purchase over \$25K, not just bids/RFP situations, but all procurements. It would be a good habit to actually screen all procurements over \$25K regardless of funding source. If you do get a positive result, we cannot do business with that vendor.

Click on SEARCH RECORDS and enter the company name. If this is a company with several names, you should search each name and include a copy of the finding in the file.



You may get several hits for the name and will have to identify the one you need. It is helpful to click on Save pdf which will provide more of a description.
