STARTING RATE or SALARY RANGE \$40,000

Employees being promoted to a higher classified position receive the minimum for the position or a pay rate adjustment of 8% whichever is greater. JOB SUMMARY:

This position is responsible for all areas of Logistics and Customs Compliance for PASSCAL supported science. It is focused on two aspects: Logistics Operations (80%) and Customs Compliance (20%). Customs Compliance:

This position will have responsibility for Import/Export customs and trade compliance related to shipping PASSCAL equipment globally. The scope of the responsibility includes the global movements of all inbound and outbound equipment, management of customs brokers, interaction with Principal Investigators regarding equipment movement and requirements/policy, compliance and US government programs and development and implementation of internal operating systems and processes.

Logistics Operations:

In addition, responsibilities include broad support of logistics operations and Principal Investigator support transportation and activities to decrease costs, optimize equipment flow and improve customer service. The position works within a team environment to provide effective communication, input and decisions from multiple other departments.

JOB FUNCTIONS:

Customs Compliance

- Develop and maintain standard operating procedures covering trade compliance in accordance with the compliance program.
- Continuously monitor government and industry developments (e.g. security, customs compliance, etc.) and maintain current information on all import/export regulations.
- Audit Import/Export documents to maintain compliance with Customs according to import/export regulations.

Logistics Operations

- Provide logistics required for PASSCAL supported science and executes. This includes scope, timing, resources, processes, procedures and documentation to complete the logistics projects.
- Consult on PASSCAL staff operational procedures for verification of incoming and outgoing shipments, handling and disposition of equipment, and maintaining warehouse inventory.
- Provides regular reporting to senior management on logistics status/issues.
